STATEMENT AND CERTIFICATION OF FINANCES**

**INSTRUCTIONS:**

Institutions are required by federal law to obtain certification that applicants have financial resources adequate to provide for their expenses while attending school. Funds may come from a variety of resources including sponsoring agencies, continuance of salary, the applicant's family, or any **dependable** source. The institution must also be assured that funds are fully documented for at least the first year of study, and that subsequent years funding will be available from the same or equally dependable sources. Institutions may issue a Form I-20 only to an applicant who is expected to be engaged in a full course of study. If you are currently on an F-1 visa and wish to transfer to Ivy Tech State College, you must attach to this document a copy of your current I-20.

You are required to state and certify the availability of US \$23,867.00 for your expenses per academic year, exclusive of travel to and from the US, and exclusive of dependent expenses. On the next page of this form indicate how you will meet the estimated expenses, as stated, below, for the anticipated duration of your program. Provide documents as required. Note that tuition, fees and estimated expenses are subject to change. Students and/or sponsors are responsible for meeting any increases in tuition and expenses. Plan for an annual increase for all costs of approximately 5% (including the first-year estimated costs below). Certain programs may require attendance (fees in addition to the below estimated expenses) during the spring/summer terms; contact the Admissions Office for additional information.

Enrollment in the College's student health insurance plan is mandatory for all international students and their dependents living in the US. (Use the table below and adjust available source of funding on reverse side as appropriate.) Applicants planning to bring dependents must also verify additional funds for each dependent (both living expenses and mandatory insurance costs as appropriate).

**IMPORTANT NOTES AND REQUIREMENTS REGARDING OFFICIAL FINANCIAL DOCUMENTATION:**

- ◆ Official and original documents must be provided. Photocopies and faxed documents will NOT be accepted. All documents must be in English and in equivalent US dollars. If documents in English are not available, translations will be accepted if signed and sealed by an appropriate government or bank official. You may wish to keep additional original documentation for your own use. Attach a copy of the I-20 from the last US institution attended, if applicable.
- ◆ All supporting documentation must be dated within six months of initial Ivy Tech State College enrollment.
- ◆ If your sponsor is a permanent resident or citizen of the US, an I-134 form, complete with all necessary supporting documentation, will be required.
